DESCRIPTION:

Use under medical supervision.

MSUD Easy Tablets are a leucine, isoleucine and valine free protein substitute tablet, containing essential and non essential amino acids.

INDICATIONS:

MSUD Easy Tablets are suitable to be used in the dietary management of Maple Syrup Urine Disease (MSUD) in patients aged 3 years and above under strict medical supervision.

DOSAGE:

Dosage to be determined by the clinician or dietician and is dependent on the age, body weight and medical condition of the patient.

11 tablets = 10 g of protein.

ADMINISTRATION:

MSUD Easy Tablets are coated (slow release) tablets which are to be swallowed whole with liquid.

STORAGE:

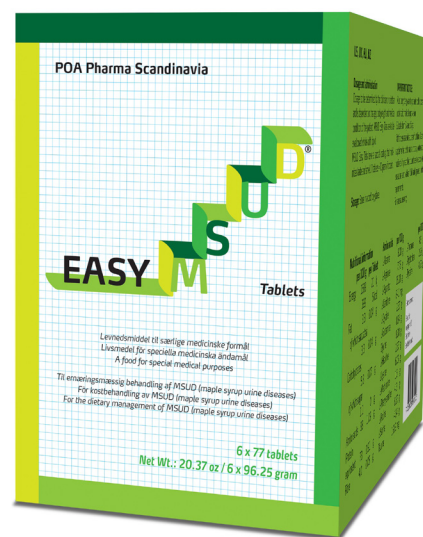
Store in a cool, dry place

CARTON SIZE:

6 bottles containing 77 tablets each

SHELF LIFE:

18 months. Once opened, the product should be consumed within one month.

- Must only be given to patients with proven MSUD under strict medical supervision.
- Suitable from 3 years of age.
- Not for use as a sole source of nutrition.
- Diet must be supplemented with natural protein, water and other nutrients in prescribed quantities to supply leucine, isoleucine and valine, fluid and general nutritional requirements.
- For enteral use only.
